Policy

- 1. 2022-23 School Calendar
 - a. The last snow day on Monday, April 17th was not a virtual day due to the unanticipated timing—we administratively discussed this early on the 17th and decided we could not effectively teach our students virtually on this day. Therefore, it was a no school day. In order to make-up this day to be compliant with DPI and contractual with the district, we changed the April 28th inservice to a student day and we moved the April 28th inservice to Monday, June 5th. Our current Employee Handbook states:

Emergency School Closures

In the event the District is closed or an individual building(s) is closed, full or partial day closures may be made up at the discretion of the District. The District shall, at a minimum make up all days/hours necessary to guarantee the receipt of state aids and/or necessary to meet the minimum annual school year requirements (days and hours) of the State of Wisconsin. Teachers shall not receive additional compensation in the event the District requires such day(s)/time to be made up with or without pupils.

With these two changes, we are now compliant with both the DPI and with teacher contracts. I announced these changes to the staff and parents on April 18th. The School Board approved these changes to the 2022-23 school calendar.

2. 2023-24 School Calendar

a. We have edited next year's school calendar once again. We added the Open House date and time on the calendar. (August 30th from 3:30-7:30) We also added the following sentence regarding snow day make-up days: "Snow days will be made up June 3-7 if needed." The School Board approved.

3. 2023-24 Employee Handbook

a. I recommended approval for changes for the 2023-24 Employee Handbook. Due to a change in Summer School pay, I would like to have the Board approve the updated employee handbook prior to the start of Summer School. The School Board approved.

Finance

a. Property Insurance Rates for 2023-24

b. We met with our insurance representative and we recommended a few changes to our renewal. We suggested we increase the property deductible (savings of \$1,716), increase the auto UM/UIM (cost \$571), and increase the linebacker deductible (savings \$264). These changes will decrease the total renewal amount to \$79,710. The largest increase is on property (+6,179) due to inflation. The School Board approved the 2023-24 Premium Total = \$79,710 This is an increase of \$9,655 from last year. (our annual renewal is on July 1st)

b. EATS Request

1. I received information from our EMC representative stating an approximate increase to our insurance would be between \$3,000-5,000 annually. Our EMC Insurance Agent was at the meeting to answer questions the Board had regarding this request. This item was tabled to a future Board Meeting, so that we can gather more information.

Information Only

1. MCSE School Psych—We are still in search for a full-time school psych for next school year. At this time, we plan on staying status quo with a 3-day part-time school psych. We are also exploring the option to work with a current school psych intern to develop a plan that once she finishes her degree she would be the full-time school psych in Edgar.
