 - 1. We have discussed this for several years and have decided it is time to increase the student fees to cover for multiple items. In discussing this with other staff members, no one can remember the fees ever being increased. This will be the first increase in 30+ years. The School Board approved increasing the student fees by \$10 each. MS/HS=\$25.00 and Elementary=\$15.00
- b. Lease Agreement
 - 1. The Mill Church requested to alter their lease to a quarterly auto-renewal moving forward, with a 30-day non-renewal notice instead of half year lease. So the lease would go from September 1, 2019-November 30, 2019 to December 1, 2019-February 29, 2020 to March 1, 2020-May 31, 2020 to June 1, 2020-August 31, 2020. The School Board approved a quarterly auto-renewal lease with a 30-day non-renewal notice.
