### Policy

- 1. Policy # 2266: Revised Policy Special Update Title IX Nondiscrimination on the Basis of Sex in Education Programs or Activities
  - 1. This policy is our current policy in which we added the first sentence: "Effective August 1, 2024, this policy shall only pertain to reports or formal complaints of sexual harassment that are based on conduct alleged to have occurred on or before July 31, 2024." The School Board approved.
- 2. Policy #2264: New Policy Special Update Title IX Nondiscrimination on the Basis of Sex in Education Programs or Activities
  - 1. This policy is the new policy in which we will utilize for any reports or formal complaints of sexual harassment that are based on conduct alleged to have occurred on or after August 1, 2024. The School Board approved.
- 3. ECCP Course Request for Fall 2024
  - 1. We have one more ECCP course that needs board approval. We have one student who would like to take Calculus II at UW Stevens Point. The School Board approved this Early College Credit Program course for Fall 2024.

- 4. 2024-25 School Calendar
  - 1. We discussed a change to the New Teacher Inservice dates in August. We recommended having one inservice day instead of two. The New Teacher Inservice is scheduled on Wednesday, August 21st. The School Board approved.
- 5. 2024-25 Athletic and Co-Curricular Code
  - 1. We made a few minor edits to the Athletic and Co-Curricular Code Handbook. The School Board approved.
- 6. 2024-25 Coaches Handbook
  - 1. We made a few minor edits to the Coaches Handbook. The School Board approved.
- 7. 2024-25 Annual Notice Handbook
  - 1. I have completed the Annual Notice Handbook for 2024-25. I receive updates from Neola in order to be sure any legal and required items have changed from past years. The School Board approved the 2024-25 Annual Notice Handbook.
- 8. Act 55 Required Notices
  - 1. The 2015-17 state budget (2015 Wisconsin Act 55) imposed a number of additional notice requirements on school districts. These requirements state that districts provide parents and guardians with notifications about:
    - i. Educational Opportunities (see document): The School Board approved the list of Educational Opportunities for the students who reside in the School District of Edgar boundaries.
    - ii. Academic Standards (see document): The School Board approved the "Notice of the Student Academic Standards in Effect for the 2024-2025 School Year," and dated July 16, 2024, as the notice was presented to the Board for the regular school board meeting held on July 16, 2024, all pursuant to section 120.12(13)(b) and section 118.30(1g)(a) of the state statutes.
