Personnel

- a. Teacher Contract Addendums
  - 1. On April 21st the School Board approved the 2021-22 Teacher Contracts. At that time, due to our compensation plan, we needed to put last year's salary on the contracts. Now that each staff member has completed their end of year meeting with the building level principals to determine their Educator Effectiveness rating I was able to prepare an addendum to their contracts. The School Board approved the contract addendum for certified staff members for 2021-22.

- b. Staff Hires
  - 1. Ms. Emily Gilmore applied and interviewed for the Elementary Guidance position. The School Board approved the hiring of Ms. Gilmore.
- c. Co-Curricular Hires
  - 1. The School Board approved the Fall Coaches for 2021.
- d. Co-Curricular Coach Position
  - 1. At this time, Volleyball is the only sport that has not had a Varsity Assistant Coaching Position. We feel this position should be considered for equity purposes and it would be beneficial for the program. The School Board approved the addition of a Varsity Assistant Volleyball Coach.

  - 1. Ms. Angela Totzke submitted her resignation as Varsity Softball Coach. The School Board approved Ms. Totzke's resignation.
- f. Intergovernmental Agreement Resolution
  - 1. The School Board approved the the Intergovernmental Agreement Resolution stating that Marathon City Public School District will again purchase art services from the School District of Edgar for the 2021-22 school year.
- g. Intergovernmental 66.0301 Contract—Shared Art Teaching Position
  - 1. The School Board approved the Intergovernmental 66.0301 Contract regarding the purchase of high school art teaching services for the 2021-22 School Year.
