Policy

- a. Election Canvassers
 - 1. The Board Clerk selected the following 3 members to be canvassers for our April 1st election: Morgan Mueller, Michelle Socha, and Lisa Nowak. The School Board approved.
- b. Policy #2340: District-Sponsored Trips
 - 1. The 2025 Track Team will be participating in a track meet on Friday, March 21st and Saturday, March 22nd at UW LaCrosse, which will involve an overnight stay. The School Board approved.
 - 2. Members of the FBLA will be traveling to Green Bay for the State FBLA Tournament on March 30th and April 1st, which will involve an overnight stay. The School Board approved.
- c. Policy #2370: Educational Options Provided By the District—we have included 10th grade students with instructor/principal approval for Dual Credit classes. Some NTC courses allow 10th grade students so we would like to change our policy to give our students these opportunities. The School Board approved for 2nd Reading.
- d. Policy #5411: Third Grade Promotion and Retention: At Risk Students—as part of WI Act 20, school districts must implement a policy for promoting students from 3rd to 4th grade. The School Board approved for 1st Reading.

- e. Neola Policy Special Update—Title IX February 2025
 - 1. Policy #2266: Nondiscrimination on the Basis of Sex in Education Programs or Activities—this policy must be revised by eliminating the first two lines. The School Board approved the revised policy.
 - 2. Policy #2264: Nondiscrimination on the Basis of Sex in Education Programs or Activities—this policy must be rescinded. The School Board approved to rescind this policy.
- f. Start College Now and ECCP Applications for 2025-26
 - 1. During the scheduling process for 2025-26 the students who have decided to enroll in SCN and/or ECCP courses have completed the paperwork. The School Board approved pending 2nd semester grades this year.

Finance

- a. CESA 9 Services Contract 2025-26
 - a. The School Board approved the CESA 9 contract for 2025-26 for the amount of \$59,338 which is an increase of \$16,746 from the 2024-25 contract. This increase is due to more days contracted for next year.
- b. CESA 10 Services Contracts 2025-26
 - a. The School Board approved the CESA 10 Contract. The cost for the CWETN services for 2025-26 is \$16,060.00. This is an increase of \$460.00 from the 2024-25 contract.
