a. Staff Hire

4. Mrs. Ashley Schilling and Mrs. Cassandra Newman have agreed to accompany the other teachers to assist at the overnight Wausau Forest trip with the 5th graders. Ashley will stay the entire time and Cassandra has agreed to only 4 hours after school. The School Board approved.
