## SCHOOL DISTRICT OF EDGAR REGULAR BOARD OF EDUCATION MEETING LIBRARY MEDIA CENTER November 15, 2023

- A. The meeting was called to order by Corey Mueller at 6:00 p.m.
- B. The Pledge of Allegiance was led by Corey Mueller
- C. Roll Call: 5 school board members (Corey Mueller, Alison Reinders, Pam Stahel, Becca Normington, Megan Wesolowski), 4 administrators (Cari Guden, Lisa Witt, Mike Wilhelm, Rich Twomey), 4 guests.
- D. Edgar School District Strategic Plan:

The district's Mission, Vision and Values statements were acknowledged by Corey Mueller

- E. Written notice of the meeting was posted and sent to the media on Friday, Nov. 10, 2023
- F. Public Participation: None
- G. Administrative Reports:
  - 1) District Administrator:
    - a) Cari Guden shared her October meeting schedule.
    - b) Cari reviewed the district's 2022-23 state report card results from the Department of Public Instruction. The report is based on students' performance on standardized tests. The district scored 68.1 overall, falling in the "Meets Expectations" category; Edgar Elementary School scored 67.1, in the "Meets Expectations" category; Edgar Middle School scored 79.6, in the "Exceeds Expectations" category; Edgar High School scored 56.3, in the "Meets Few Expectations" category. A local report card (developed separately) provides data on additional measures to give an overall picture of the schools' performance. The local report card is linked in the district's description included in the state report card.
    - c) Communication:
      - 1) Cari shared Marathon County Special Education Board highlights
  - 2) Staff/Student presentations:
    - a) Student presentation: Three students were present to describe Edgar High School's participation in the Marawood Leadership Conference at Marathon High School. Six Edgar students attended the event. They developed an action plan to create a more positive environment in the school.
  - 3) Administrators
    - a) **Elementary principal** Lisa Witt reported on:

- 1) Veteran's Day program coordinated by Colin Hanson. Veterans visited classrooms to tell their stories, and then attended a luncheon in their honor.
- 2) November Family Night Nov. 16. Promoting literacy. Author and motivational speaker Julia Cook will read her book "Bubblegum Brain," and will hold a book signing. Donations to the United Way Mobile Closet will be accepted.
- 3) In-service will be held Nov. 20-21. Focus will be ELA professional development.

- b) High school principal Mike Wilhelm reported:
  - 1) End of Quarter 1 was Nov. 3. Report cards went out Nov. 8
  - 2) Veteran's Day program Nov. 10 The program featured women veterans, local and from around the state, as part of the "I Am Not Invisible" program acknowledging the contributions of women to the military.
  - 3) Edgar Theater Company performed "Into the Woods" Nov. 9-12. Culinary Arts students cooked and served meals to patrons prior to performances.
  - 4) Cat Teams Rich Twomey will provide more information on this.
  - 5) BASC/BESS screeners were held
  - 6) Upcoming in-service days Nov. 20-21.
  - 7) The football team is playing for the state championship tomorrow.
- c) Special education coordinator Rich Twomey
  - MS/HS Student Intervention Planning (CAT teams): Goal is to identify and support struggling students. Addressing academic and behavioral struggles. The program was adapted from a program used at the elementary school for years.
  - 2) Q1 progress reports: For kids with IEPs, report whether IEPs are on track to meet the IEP goals, and outline action steps if they are not on track.
- d) **Board member report**: Becca Normington attended the last Village Board meeting. Board members discussed Colin Hanson's exceptional work organizing the Veteran's Day program and other community events each year.
