- 4. Support Staff Hires
  - a. Ms. Tonia Schilling applied and interviewed for our full time night custodian position. The School Board approved this hire.

- 5. Designate Legal Counsel Change in Firm
  - a. Attorney Dean Dietrich is transferring to the Law Firm of Weld Riley, S.C. The School Board approved that we continue utilizing Attorney Dietrich as needed through his new law firm.
- 6. Student Teachers for 2<sup>nd</sup> Semester
  - a. Grade 4 will be hosting a student teacher, Tanner Schlender, for the entire second semester. The School Board approved.
  - b. Kindergarten for quarter 3 and Grade 1 for quarter 4 will be hosting a student teacher, Kamryn Butt, for the full second semester. The School Board approved this hire.

# Policy

- 1. COVID Procedures—I do not recommend any changes to our current COVID-19 Procedures. No action was taken.

  - a. The policies in Volume 30 Number 2 have all been thoroughly prepared and reviewed by Neola's legal counsel for statutory compliance. The following policies are new to Edgar School District: #0143, #5720, #5880. The policies related to discrimination and harassment on the basis of a protected class have been revised to comply with the new Title IX regulations. The School Board approved the 1<sup>st</sup> Reading for all of these polices.

#### Finance

- 1. Increase Lunch and Breakfast Prices for Adults
  - a. As of Dec. 31st the following changes are required: \$4.65 lunch and \$2.56 breakfast for adults only. We currently charge \$3.95 for lunch and \$2.05 for breakfast. The School Board approved.
- 2. Finalize 2021-22 District Budget
  - a. Board Approval of Budget 2021-22. The School Board approved the 2021-22 Budget as printed.
- 3. Review Revenue Limit and State Aid
  - a. We are able to tax the difference between the Total Revenue Limit and the State Aid which equals \$1,244,929. Given that information you will see that I requested and the School Board approved that we levy to our maximum.

#### 4. Set Tax Levy

- a. Our total levy decreased -5% and the Equalized Value increased 3.5% with a mil rate decrease of -8.2%. Several items contribute to this:
  - 1. Equalized value increased
  - 2. Transfer of Service increased (\$15,686 to \$26,486)
  - 3. Total Revenue Limit stayed relatively flat
  - 4. Referendum levy increase \$200,000 purposely to mitigate the mill rate
  - 5. State Aid increased (\$193,186)—this is one of the main reasons for the mill rate decrease
    - a. 2016-17 Equalized Aid = \$4,881,319.00
    - b. 2017-18 Equalized Aid = \$4,702,806.00
    - c. 2018-19 Equalized Aid = \$4,639,781.00
    - d. 2019-20 Equalized Aid = \$4,526,381.00
    - e. 2020-21 Equalized Aid = \$4,819,630.00
    - f. 2021-22 Equalized Aid = \$5,013,199.00

The School Board approved the tax levy of 0.00946292 which equates to \$9.46 per thousand of value (example: on a home valued at \$100,000 the school tax would be \$946.00 for the year)
