Policy

- a. Neola prepares updates and revisions to the policies throughout the year and then these updates are sent to me twice a year. This process typically occurs in June and December. I have received the legal updates and met with Steve to discuss the updates. The School Board approved these policies for 1st reading.
- b. Overnight Fieldtrip Policy #2340
 - a. Mr. McCarty discussed several overnight fieldtrip opportunities. The School Board approved the following overnight fieldtrips:

 - ii. National FFA Convention, Indianapolis, IN: October 29-November 1

- c. Foreign Exchange Student Policy #5114
 - a. Jill Mielke, AFS Region Coordinator, contacted me to ask if we would be willing to accept another foreign exchange student. I explained to Jill that according to Federal law and Edgar Board Policy #5114, a district could only accept 5 exchange students; however, the policy states that the School Board can approve more than 5 students. The School Board approved an additional exchange student to begin as soon as possible.

Finance

- a. Amended 66.0301 Contract—Shared Art
 - 1. There has been a slight change with the % split between Edgar and Marathon School Districts. The previous contract split showed Edgar=56% and Marathon=44%. The updated contract split shows Edgar=49% and Marathon=51%. The School Board approved these changes.
- b. Sale of Donated Stock
 - 1. The late, Mr. Stephen Kavajecz, has donated Five Hundred (500) shares of stock in Schering-Plough Corporation to the Edgar High School Scholarship Fund, Edgar, Wisconsin, to be as a part thereof and a further addition thereto and not a separate trust. With the assistance of Attorney Dean Dietrich, we have been working through the process to complete this transfer/sale. We also have been working with Judy Trawicki at Whalen Financial Group to set up a brokerage account so the stock can be transferred and then sold. We plan to sell the stock and move the money to the Scholarship fund at Advantage Community Bank. The School Board approved the transfer and sale of this stock in the approximate amount of \$42,000.
- c. Short-Term Borrowing Resolution
 - 1. Resolution authorizing temporary borrowing in the amount not to exceed \$1,800,000.00 pursuant to Section 67.12(8)(a)1, Wis. Stats
- d. Short-Term Borrowing Bids
 - 1. Mrs. Mueller shared that she received two bids for the short term borrowing. The bids came from Oppenheimer and BOK Finance. The School Board approved the lower of the two bids (Oppenheimer) at 1.7736%.
