SCHOOL DISTRICT OF EDGAR REGULAR BOARD OF EDUCATION MEETING LIBRARY MEDIA CENTER November 16, 2022

The meeting was called to order by Gary Lewis at 6:00 p.m.

The Pledge of Allegiance was led by Gary Lewis

Roll Call: 4 board members (Gary Lewis, Pam Stahel, Becca Normington, Megan Wesolowski) 3 administrators (Cari Guden, Lisa Witt, Tom McCarty), 8 guests

Public Participation: Tom Normington presented on behalf of the Edgar Area Trail Supporters (EATS) organization to discuss the use of school forest trails and to initiate a request to build an equipment storage shed on school property.

Staff/Student presentations:

- Mr. Matt Reinders and FFA members presented on recent FFA activities and on goals for the year.
 - FFA has expanded to allow middle school participation. There are 97 FFA members this year (58 high school, 39 middle school).

Administrative Reports:

- District Administrator: Cari Guden reviewed her October meeting schedule. She
 reported Marathon County Special Education October Board highlights. She presented
 information about the opportunity for Edgar School District to have an electric bus
 through Fisher Transportation. She is waiting for additional information from the bus
 company before making a decision. The State Education Convention will be held January
 17-19 in Milwaukee. Cari Guden and Becca Normington will plan to attend. Becca will be
 the district's delegate.
- Elementary principal: Lisa Witt reported on Veteran's Day activities. The November 17
 Family Fun Night will feature an escape room. November inservice dates are Nov. 21-22.
 Other dates include elementary concert on Dec. 8, December Family Fun Night Dec. 15,
 Fifth graders will visit the Wausau School Forest Dec. 20-21.
- High school principal: Tom McCarty reported on the Nov. 8 Veteran's Day assembly featuring Melissa Stockwell, who was injured in the Iraq war, and her journey to become a paralympic triathlete. Nov. 11 veterans visited school and FCCLA members cooked a meal for them, and music students performed for the veterans. Overnight field trips include: students who qualified for state band; wrestling trip. Inservice will be held November 21-22. Grades 6-12 will have remote learning on Nov. 21. Band and choir concerts will be Dec. 8.
- Cari Guden reported on behalf of Morgan Koroch (Special Education Coordinator) on special education updates.

The motion carried unanimously.
